Call to Order

- Enchiladas with fideo and dessert scheduled for an upcoming event.
- Discussion on using larger tortillas and providing generous portions to guests.

Music and Entertainment

- Loss of patrons noted with the absence of a DJ; suggestion to open events to non-members to increase attendance.
- Consideration of live bands or DJ for future events to attract more guests.
- Emphasis on inviting local community to events to increase turnout.

Facilities and Equipment

- Discussion of purchasing covers and organizing the storage of equipment to clear space.
- Received donation of a new freezer; plans to discard old equipment.
- Planning for the repair and maintenance of the outdoor barbecue grill.

Old Business

- Recap of financial transactions from past events.
- Discussion on ongoing fundraising through ticket sales for bottled item raffles.

Meeting Adjustment Proposal

- Proposal to move regular meetings to Tuesday evenings for better attendance and participation.
- Motion was put to vote and accepted to change meeting days.

Fundraising and Community Engagement

- Ideas thrown around for future events like chili cook-offs, live bands, and beer bundle sales.
- Suggestion to draft a proposal for a Legion-supported event with potential beer sales.

Membership and New Business

- Introduction of new members and discussion on streamlining membership applications.
- Implementation of automated payment systems for event transactions.
- Proposal to hold more community-involved events to raise money and visibility.
